



**{ INSTRUCTIONS }**

1. Officers surrendered by senior management will be posted on special duty in HRD Section and shall not be considered for reposting without specific approval of Collector. SPS HRD shall mark the officer's attendance in his office at 9am and 5pm to ensure the officer's presence and shall be personally liable for any violation/lapse on this account.
2. All Preventive officers are strictly directed to be in uniform during the discharge of their duties and record their movement in duty attendance register and not to leave their place of posting until & unless properly relieved. Any lapse in this regard shall be viewed seriously and disciplinary proceedings under existing rules shall be initiated against the incumbents. Any officer, if not found on duty, would be dealt as per law. Proper Log Book and reports should be maintained in weach each shift.
3. SPS Assessment shall verify the particulars declared by the passenger in Baggage Declaration as envisaged under Section 139 of the Custom Act 1969 before processing of Baggage Declaration.
4. THE SPS / IPS posted at PMBQ Gates shall visit Gates including Off-Dock Terminals on regular basis and submit a report to Deputy/Assistant Collector, Collectorate of Customs Enforcement immediately in case of any issue.
5. Above officers are directed to get their One-Customs/WeBOC internal user IDs immediately from office of Deputy/Assistant Collector (Hqrs)/MIS. SPS(Administration) shall coordinate with MIS Section regarding issuance of IDs and shall certify in writing that all officers have got their respective IDs within 24 hours.
