

SPS HRD shall mark the officer's attendance in his office at 9am and 5pm to ensure the officer's presence and shall be personally liable for any violation/lapse on this account.
2. All Preventive officers are strictly directed to be in uniform during the discharge of their duties and record their movement in duty attendance register and not to leave their place of posting until & unless properly relieved. Any lapse in this regard shall be viewed seriously and disciplinary proceedings under existing rules shall be initiated against the incumbents. Any officer, if not found on duty, would be dealt as per law. Proper Log Book and reports should be maintained in weach each shift.
3. SPS Assessment shall verify the particulars declared by the passenger in Baggage Declaration as envisaged under Section 139 of the Custom Act 1969 before processing of Baggage Declaration.
